



## TERMS & CONDITIONS FOR VISITING TEAMS

**TRAINING SPACE:** Training space is available at Nathan Benderson Park, Fort Hamer Park, Blackburn Point and Bay Preserve- Osprey. On the Request Form please list your order of preference for your training visit. We will do our best to accommodate everyone's first preference.

**CHECK-IN:** All teams must check-in and check-out with the on-site parks division staff during office hours to:

- Verify all necessary paperwork is in order
- Pay any outstanding facility user fees
- Receive area assignments from staff and parking

**BOATHOUSE SPACE:** Boathouse space is available but limited at Ft. Hamer. Storage is also on a first come, first serve basis at other facilities.

**ROWING AREA ACCESS:** Access to the rowing area is limited to foot traffic only, except for setup, take down, and removal of equipment. Since space is limited we ask that you keep your equipment and the surrounding area as compact and clean as possible.

**WATER ACCESS:** Hose bibs are provided at the Ft. Hamer facility, but hoses must be provided by visiting team. Please conserve and turn off water when not in use.

**PARKING:** Please park all team transportation vehicles in the parking lot adjacent to the facilities restroom building at Ft. Hamer. At no time shall vehicles block roadways or other driveways at any of the facilities.

**GENERAL ACCESS TO THE PARK:** Please remember that Nathan Benderson Park, Fort Hamer Park, Blackburn Point and Bay Preserve- Osprey are County parks that are open to the general public. We ask that you please be considerate to others utilizing the various facilities which are reserved and utilized on a regular basis.

**SECURITY DEPOSIT:** A security deposit (\$50.00 for 1 to 100 athletes or \$100.00 for 101+ athletes) is required for all organizations utilizing Nathan Benderson Park, Fort Hamer Park, Blackburn Point and Bay Preserve- Osprey. A deposit in the form of a separate check made out to 'SANCA' will be returned to your organization upon inspection by park staff and determination that no damage or clean-up expenses have been incurred.

**CHECK-OUT:** Notification must be given to park staff. Pick up security deposit upon verification from park staff, if applicable.

The facility fees are as follows:

**Administrative Fees**

**Daily Fees:** \$5/athlete/day for use of one facility

\*Use of multiple facilities will incur additional fees

**Launches:**

\$25/hr with engine \$75 max/day

\$15/hr without engine \$45 max/day

Please note: workout equipment is available at Ft. Hamer at an additional charge.

The administrative fee and 25% of the total daily athlete fees are due along with your signed contract that will be provided by SANCA once your application has been reviewed and training dates approved. The administrative fee is nonrefundable; while the 25% of total daily athlete fee is refundable up until 90 days prior to the training start date. All additional fees collected prior to 90 days of scheduled training date shall be considered refundable.

If application is received within 90 days of requested training start date, all fees associated with training will be due upon training date approval and will be considered non-refundable.

If the Agreement is executed by SANCA, and Licensee cancels the Training or otherwise notifies SANCA, within 90 days of the actual event start date, that it does not intend or is not exercising its license rights or if Licensee otherwise defaults under the Agreement, said deposit and all other monies paid by Licensee to SANCA shall become the sole property of SANCA, and SANCA shall be entitled to pursue collection of any other monies owed by Licensee pursuant to this Agreement. Licensee shall also be responsible for the payment of all applicable sales and license taxes, and other costs, fees, fines or damages as may be required pursuant to this Agreement.
